1 Sign up to the Enable Program, activating our Enable Guarantee - you will not pay any fees until you receive a refund.

2 We begin your Disability Tax Credit (DTC) refund process with a comprehensive discovery call to build a personalized profile for you.

3 Our DTC experts submit your claim to The Canada Revenue Agency (CRA) on your behalf.

4 Once The CRA has approved your claim the refund is paid directly to you.

5 Once we receive CRA authorization, our tax experts review your 10-year tax history within 5 to 7 days to determine the money you are entitled to.

6 Our Benefits Specialist will liaise with your medical practitioner to sign-off your documentation.

7 The CRA processes your claim within 120 days.

Understanding the Disability Tax Credit

What is the Disability Tax Credit?

The Disability Tax Credit (DTC) is a non-refundable tax credit offered by the Canadian Government to individuals who have a medical condition that affects daily living. The purpose of the DTC is to reduce the amount of income tax that people with medical conditions, or their supporting family members, may have to pay.

How Does the DTC Work?



Eligibility:

To qualify for the DTC, a medical practitioner must sign off that you have a medical condition which affects your daily living.



Application Process:

The application involves completing the Disability Tax Credit Certificate (Form T2201) and having it signed by a qualified medical practitioner. Enable Benefits manages the entire process for you, ensuring all paperwork is correctly completed and submitted.



Tax Relief:

Once approved, the DTC can be claimed retroactively for up to 10 years, resulting in a substantial refund of up to \$45,000 for an adult or up to \$60,000 on behalf of a minor.

Understanding the Canada Caregiver Credit

What is the Canada Caregiver Credit?

The Canada Caregiver Credit (CCC) is a tax refund that can be claimed by individuals who have supported a family member with a medical condition. This money helps to offset some of the expenses incurred while caring for a loved one in need.

How Does the CCC Work?



Eligibility:

You are eligible if you support a family member, or dependent with a physical or mental impairment. The dependent does not have to live with you to qualify.



Tax Relief:

Once approved, the CCC can significantly reduce the amount of tax you owe, resulting in a substantial financial refund for caregivers.



Refunds:

The Canada Revenue Agency (CRA) deposits your refund directly into your bank account.
